I understand that my spaces will be guaranteed once I have sent the full deposit and agreement form and receive a confirmation letter.

I hereby release Souled Out Ministries from any responsibility for any injury or death that may occur during or on the way to or from the Souled Out student conference at the beach during the dates indicated above. I understand that I am responsible to oversee, provide and keep my own release forms for each person in my group. I acknowledge that my church/organization is responsible for the well-being of the people that we bring to the conference. I understand that lifeguards will not be provided at the conference, so I will be responsible for my own group's safety and regulations regarding swim time, etc. I acknowledge that Souled Out suggests that I provide lifeguards and specific swim times and rules for my group. Although the number of chaperones is up to our group, I acknowledge that Souled Out suggests that we provide at least one chaperone for every seven students and at least one chaperone in each small cabin. These adults will be responsible for the well-being of the students while they are at the conference.
